As a follow-up to our August 3, 2021, All Client Memorandum I would like to share the results of our 2020-2021 End of the School Year Client Survey and an update regarding our 2021-2022 Workshops.

### 2020-2021 End of the School Year Client Survey

As you may recall, we sent an email on April 30, 2021, requesting that you complete (sometime prior to May 21, 2021) our annual “end of the school year” survey regarding the services provided by SCLS. We collected survey responses from 60 respondents. We appreciate the feedback from all of our clients that responded. The results of the survey demonstrated significant satisfaction with the services provided by SCLS. Please see attached a two-page summary of the survey results. We are pleased at the positive feedback! We will strive to continue to improve the delivery of legal services to our clients.

### 2021-2022 Workshops

As you may recall, our office was planning to present our workshops this school year in a hybrid manner with an in-person option and a remote option via Zoom through Swivl. Due to the low number of participants that are selecting the in-person option and due to factors associated with COVID-19, all of our workshops from now through September 22, 2021, will be presented via Zoom only – there will not be an in-person option. For workshops scheduled after September 22, 2021, our office will be making a workshop-by-workshop decision on whether to offer an in-person option or to only provide a remote option via Zoom. Our office will be contacting anyone registered to attend a workshop in-person and timely informing them if the workshop switches to remote Zoom only participation.
