#### Jessica Ozalp

Jessica Ozalp joined our office on August 22, 2022, in the role of Associate General Counsel. Many of you have had the pleasure of working with Ms. Ozalp already.

Ms. Ozalp is a former educator and has almost a decade of experience in school law. She counsels clients on issues such as personnel investigations and discipline, Uniform Complaints, sexual harassment and Title IX compliance, charter school oversight, Brown Act compliance, and conflict of interest laws.
